**Re: Nauru Maritime and Port Authority (NMPA) – implementation of Temporary COVID – 19 Levy**

Dear Valued Customers,

Neptune Pacific Line (NPL) wishes to advise our customers that notification was received on 31<sup>st</sup> August 2020 from Nauru Maritime and Port Authority (NMPA) with regards to the immediate implementation of a temporary COVID – 19 levy on all imports, containerised and break bulk and with immediate effect applied to all cargo vessels discharging cargo in Nauru.

For NPL the above surcharge would become effective on import cargo discharged on the Capitaine Quiros v89 eta Nauru 4<sup>th</sup> October 2020.

The quantum of this import Covid – 19 levy is; AUD 500/teu and AUD 50/m3 for break bulk cargo.

NPL sort clarification from NMPA with regards to surcharge quantum and immediate implementation date. NMPA responded on 3<sup>rd</sup> September 2020 confirming there is to be no change to tariff notice.

**Implementation of this Nauru Port and Maritime Authority surcharge**

The above surcharge will apply on a *prepaid* basis to all cargo received and loaded on the **Capitaine Quiros v 89** commencing in **Suva 25<sup>th</sup> September 2020** and continue until further notice.

NPL apologises for any inconvenience caused as we sort and received clarity on this position and we undertake to ensure our customers are kept apprised of this developing position.

For ease of reference, attached is the notice received from Nauru Port and Maritime Authority.
