## Republic of Nauru – Port Charges

Dear Valued Customers,

The Republic of Nauru Port Authority has issued an Extraordinary Gazette outlining its Nauru Port Tariff charges which has come into effective January 2016..

Neptune Pacific Line (NPL) has formally written to the Nauru Port Authority executive, requesting that due to the magnitude of these increases that they are immediately reconsidered however to date are awaiting a formal response. In the interim period, NPL have no alternative but to on pass these applicable increases in Nauru.

List of relevant port charges being increased include;

- **Port Entry** – has increased from \$4255 to \$ 8509
- **Berthage** – has increased from \$ 2836 to \$ 10637
- **Moorage** – has increased from \$ 2236 to \$ 3546
- **Pilotage** – has increased from \$ 3546 to \$ 4964
- **Wharfage** – has increased from \$ 150 to 500 (full / empty as outlined within below table)

List of new charges include;

- **Marine Navigation levy** – applied at \$ 496
- **Environment levy** – applied at \$ 155

NPL will pass the relevant cost increases imposed by Nauru Port Authority by increasing the current Terminal Handling Charge (THC) effective **Capitaine Quiros v52nb** as follows;
